(Central Act No.6 of 2014)

ORDER:-

Whereas, by section 101 of the Andhra Pradesh Re-organisation Act, 2014 (Central Act No.6 of 2014), the appropriate Government i.e the State of Telangana is empowered by order, to make such adaptations and modifications of any law (as defined in section 2 (f) of the Act) made before 02.06.2014, whether by way of repeal or amendment as may be necessary or expedient, for the purpose of facilitating the application of such law in the State of Telangana before expiration of two years from 02.06.2014; and thereupon every such law shall have effect subject to the adaptations and modifications so made until altered, repealed or amended by a competent Legislature or other Competent Authority;

And whereas, it has become necessary to adapt "The Andhra Pradesh Panchayat Raj Act, 1994" and "The A.P. State Panchayat Raj (Salaries and Allowances and Condition of Service of State Election Commissioner Rules, 1994" for the purpose of facilitating their application in relation to the State of Telangana;

Now, therefore, in exercise of the powers conferred by section 101 of the Andhra Pradesh Re-organisation Act, 2014 (Central Act No.6 of 2014), the Governor of Telangana hereby makes the following Order, namely:-

1. (1) This Order may be called the Andhra Pradesh Panchayat Raj Act, 1994 (Telangana Adaptation) Order, 2014.

(2) It shall be deemed to have come into force with effect from 02.06.2014.
2. In this Order, the 'law' i.e. "The Andhra Pradesh Panchayat Raj Act, 1994" being adapted in this order shall have the same meaning as defined in section 2 (f) of the Andhra Pradesh Reorganisation Act, 2014.
3. The Andhra Pradesh General Clauses Act, 1891 applies for the interpretation of this Order as it applies for the interpretation of a State Act.
4. In the Andhra Pradesh Panchayat Raj Act, 1994 throughout the Act (except occurring in the citation of other Acts) for the words "Andhra Pradesh" the word "Telangana" shall be substituted.
5. As from the appointed day, the Andhra Pradesh Rules mentioned in the Schedule to this Order, shall, until altered, repealed or amended by a competent Legislature or other competent authority, have effect subject to the adaptations and modifications directed by that Schedule.

6. For the purpose of this Order, and the Act and Rules adapted herein the expression "the State" shall have the meaning and area as specified in section 3 of the Andhra Pradesh Reorganisation Act, 2014.
