**ORDER:**

The Government vide G.O. 4<sup>th</sup> read above have issued orders approving the Panel of Assistant Director of Town Planning for the Panel Year 2016-2017 for promotion to the Post of Deputy Director of Town Planning.

The Government vide G.O., 6<sup>th</sup> read above have issued orders promoting Smt.K.Uma Devi, Assistant Director of Town Planning, temporarily Under Rule 10 (a) of Telangana State and Sub-ordinate Service Rule,1996, to the category of Deputy Director of Town Planning (Category-IV) of Town Planning Service Rules, 1992, in the scale of **Rs.46060-1270-49870-1360-53950-1460-58330-1560-63010-1660-67990-1760-73270-1880-78910-2020-84970-2160-91450-2330-98440/- (RPS-2015).**

The Government vide G.O.,8<sup>th</sup> read above have posted Smt.K.Uma Devi, DDTP, at GHMC, Hyderabad, on her promotion, with immediate effect.

The Officer is hereby directed to report before the Commissioner, GHMC, Hyderabad in the promotion post of DDTP/DCP immediately.

The Commissioner, Nizamabad Municipal Corporation, is requested to relieve Smt.K.Uma Devi, so as to enable her to join her new station and intimate the date of relieve to this office for information and record.

The Commissioner, GHMC, Hyderabad is requested to admit the above officer in the promotion post of DDTP/DCP and intimate the date of joining to this office for information and record.

Pending fixation of her pay in the post of DDTP, she is allowed to draw her own pay or the minimum of the scale of the post of DDTP whichever is higher. She is also required to submit her option within one month time from the date of joining duty.

The above promotion is given subject to the following conditions:

- (a) The appointment by transfer to the post of DDTP in the exigencies of service and purely on temporary basis
- (b) She is liable to be reverted without assigning any reasons and also without giving any notices

- (c) The appointment is purely on temporary basis and also without prejudice to outcome of O.As and also W.Ps/R.Ps/W.As/SLPs and appeals pending if any in the department, APAT, Courts and also with the Government etc., subject to out come of disciplinary cases if any.

Further she is informed that if she fails to join duty in the new post to which she is promoted and posted within 15 days from the date of receipt of this order, her promotion is deemed to have been cancelled automatically and she will cease to hold any right of promotion both for present and future.


